Rabies tag must also be worn. **Dogs must remain on leash at all times.**

This walk is to honor the late Senator Pat McGee, NYS senator from Chautauqua County, who supported Buster's Law. Buster's Law was named after an 18-month-old tabby cat was doused with kerosene and burned to death by a Schenectady teenager in 1997. The Felony Animal Cruelty Law established that "aggravated cruelty to animals" is a felony offense punishable by up to two years in prison and a \$5,000 fine.
